The Purpose of a Vaccine is to Make You Immune to Disease

- If you are immune, you can be exposed without being infected
- If you are immune, you cannot transmit the disease

COVID Injections are NOT! Vaccines

- Increasing numbers of people get “COVID” even though they were “vaccinated” against it
- “Break-through cases” and deaths following injection outnumber unvaccinated “cases”

What's in the Injections?

- Modified Spike Protein mRNA/DNA (very toxic)
- Graphene (very toxic)
- Variety of lipid nanoparticles (range of toxicity)
- Heavy metals: Fe, Ni, Cr (toxic)
- Various unidentified synthetic materials (toxicity?)

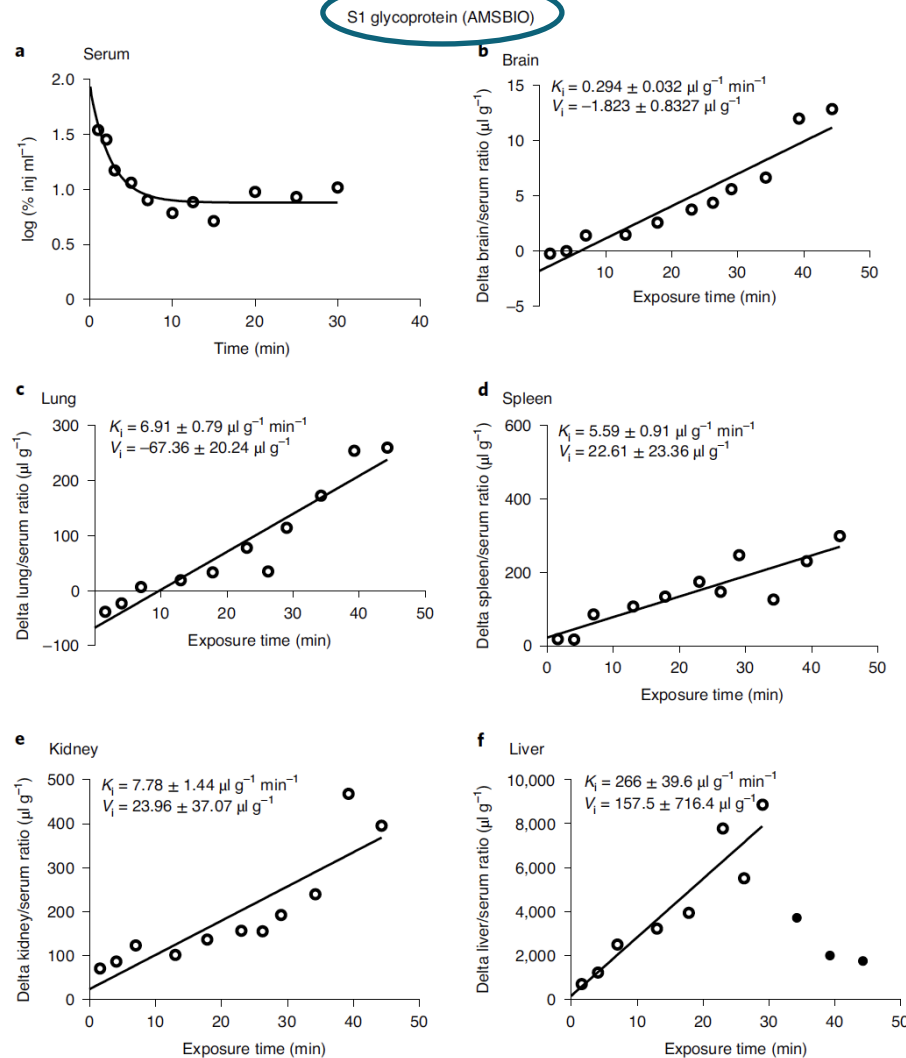


Fig. 3 | I-S1 (AMSBIO) is cleared from blood and taken up by peripheral tissues. a, Clearance of I-S1 from AMSBIO from blood. Data were fitted to a

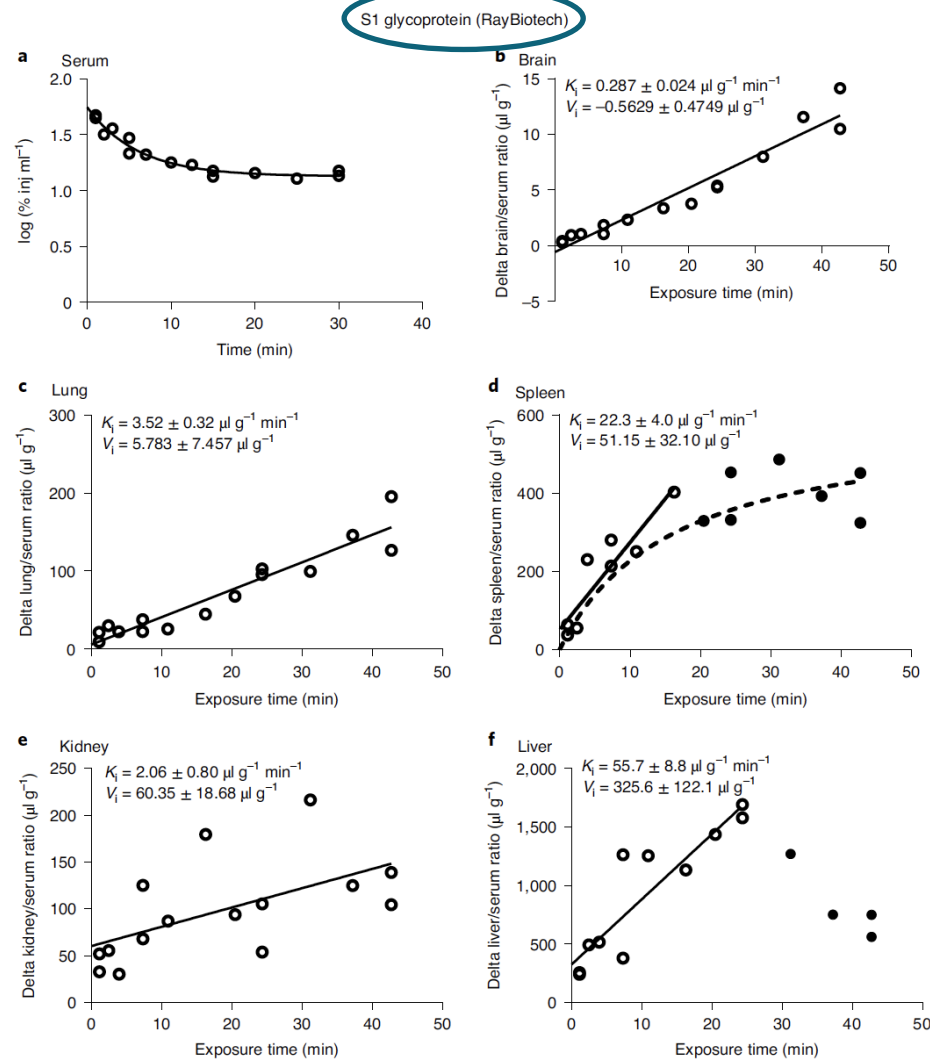
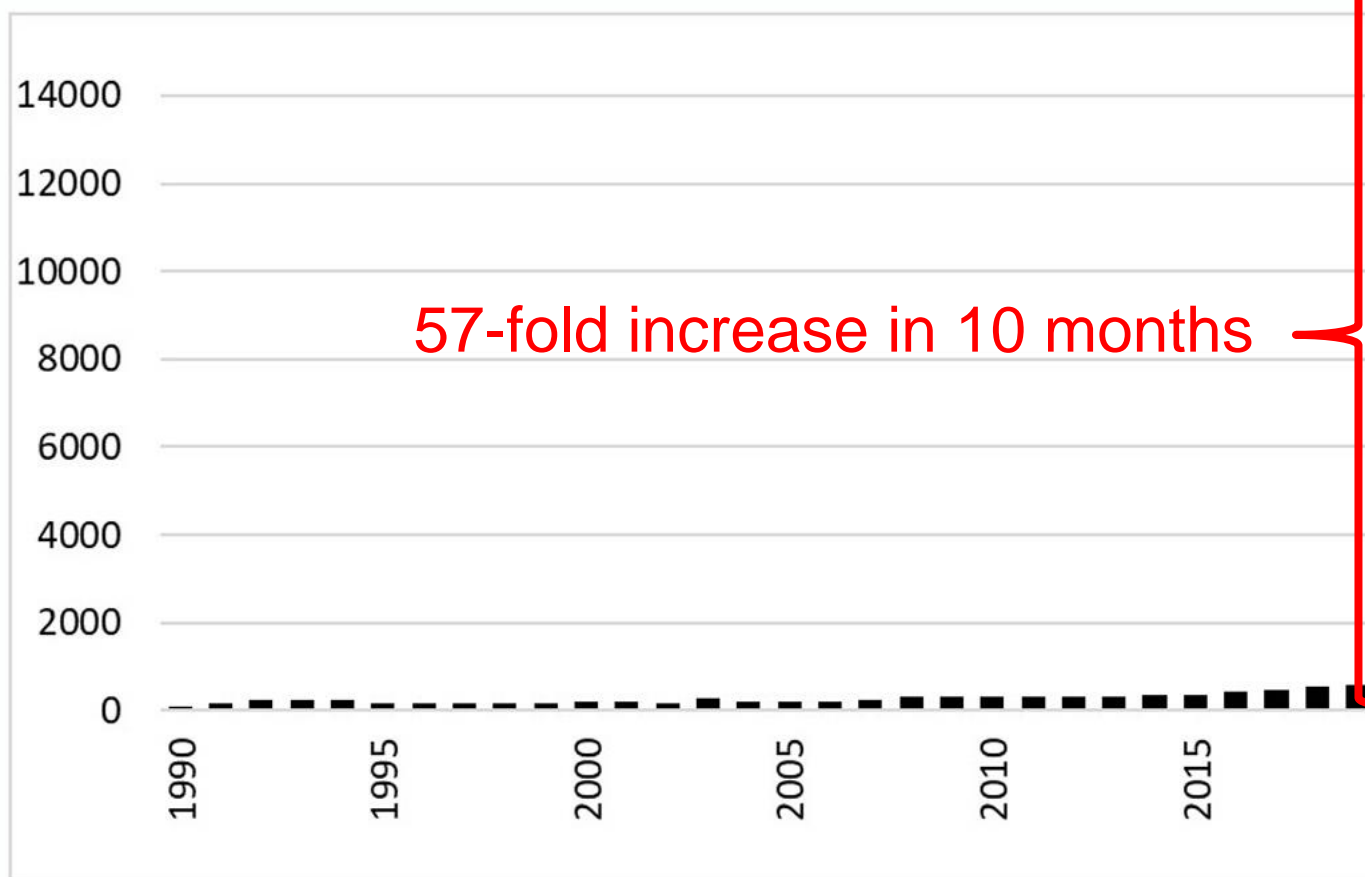


Fig. 2 | I-S1 (RayBiotech) is cleared from blood and taken up by peripheral tissues. **a**, Clearance of I-S1 (RayBiotech) from blood. Data were fitted to

- 1986 National Childhood Vaccine Injury Act
